- Artists must provide a Biography Photo, Artist Statement and or Biography for artist Page.
  - Provide links to Website and or social media.
- Artists must provide Product Photos of all submitted work.
  - Photo file names must be structured: ARTIST NAME - TITLE OF WORK - PRICING
    - EXSAMPLE: SONIA CARILSE - PORTRAIT STUDY - 250.50
  - Use Google Drive to Store and Share edited and prepared photos.
- Artist's work will be used in promotional social, print and other advertising purposes.
  - The use of photos will remain the property and use of The Tattooed Lady even after cancellation of agreement or membership.
- Artist's work will be displayed in The Tattooed Lady Fresha Online Store.
- All Artists must serve on at least one gallery committee and Juried Exhibition.
- All Artists will receive free submissions to Juried Exhibition and or Gallery Events.
- Artists must 5-6 months create, swap and update inventory by supplying new work and or objects.
  - All objects or work must be approved before displaying or exhibiting. Artists are responsible for storing, removing artwork that is to be replaced by new pieces.
- All artists must have email and phone access.
  - Artists will be paid using PayPal. If you have any questions and or concerns just ask.
  - Commision will be paid on Fridays Weekly.
